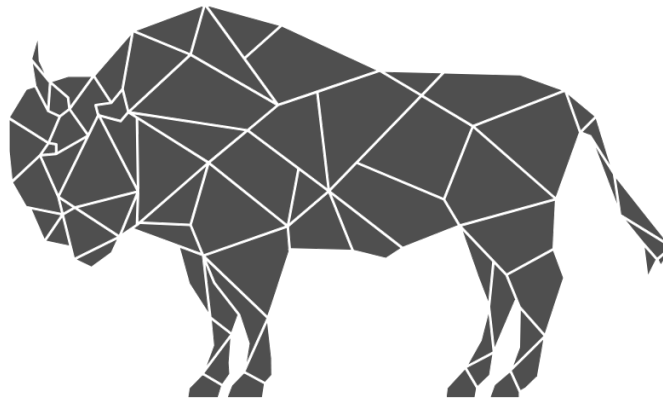

# Northern Lights Camp

## Terms of Use

Northern Lights Camp is a private camp, owned and operated by the Dakota Conference of Seventh-day Adventists. The primary purpose is to provide a natural setting designed to serve the needs of the Dakota Conference, its members, youth and invited guests.

### General Regulations

1. Persons who use the camp must register with the group representative upon arrival and check-out upon departure.
2. Neither the Dakota Conference nor its staff, volunteers or camp committee will be responsible for losses or accidents which may occur on camp property.
3. Campfires are permitted in designated areas only and must adhere to state and federal fire building safety codes and danger indexes.
4. Campers are expected to keep the grounds, cabins, restrooms, cafeteria and lodge clean and orderly at all times. Anyone using the camp will be responsible for damages.
5. **This is a kosher kitchen.** Use of the kitchen must comply with posted health department and use codes. Dishes, linens and equipment must be left clean.
6. Alcoholic beverages, tobacco, illegal drugs and those under their influence are not permitted on the premises.
7. Cutting, carving or defacing trees or other natural features is strictly forbidden.
8. Visitors are discouraged from bringing pets. Should you choose to bring a pet:
  - a. You will be responsible for the cost of repairing any property damage your pet causes. The camp is not responsible for loss or injury to persons or pets.
  - b. Pets are not allowed in the cafeteria or dining area.
  - c. Pets must be kenneled if left indoors. Do not leave a pet tethered or otherwise unattended for long periods of time.
  - d. Please leave the area as you found it. You must pick up after your pet.
  - e. Should your pet become a nuisance to others, you will be asked to remove it. Animals **of any breed** that are hostile or aggressive are not allowed. If your pet is too vocal, you will need to find other accommodations.
  - f. Dogs running loose have been known to share poison ivy with humans. Please keep your dogs on a leash.
9. Use of four-wheelers, ATVs, or any other motorized vehicles on trails is not permitted except for staff usage.
10. Leave all facilities cleaner than you found them. Sweep all floors, vacuum all carpeted areas and clean all bathrooms thoroughly. Please follow the cleaning instruction sheets posted in each building.
11. Dakota Conference reserves the right to refuse service and/or deny access to the property.
